1. **Lekam Rural Municipality, Office of rural municipal executive ratamata, darchula** invites sealed bids or electronic bids from Nepalese eligible bidders for the Procurement of Supply, Delivery and Installation of Portable USG and supporting equipment under National Competitive Bidding procedures. The estimated amount for the works is Rs 25,97,267.33 (In word twenty five lakh ninty seven thousand two hundred sixty seven rupees and thirty three paisa only with VAT).

Bidders, submitting their bid electronically, should deposit the cost (as specified above) of bidding document in the Project's Rajaswa (revenue) account as specified below and the scanned copy (pdf format) of the Bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids. 5. Sealed or electronic bids must be submitted to the office **Lekam Rural Municipality Ratamata Darchula** by hand/ courier or through PPMO website [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp) on or before **12.00 pm on jun 25 2023**. Bids received after this deadline will be rejected.
6. The bidswill be opened in the presence of Bidders' representatives who choose to attend at **10:00AM, jun26, 2023** at the office of **Lekam Rural Municipality**. Bids must be valid for a period of **90 days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in .pdf format in case of e-bid, amounting to a minimum of Rs **80,000**, which shall be valid for 30 days beyond the validity period of the bid.
7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
