Lekam Rural Municipality Office has received a grant from GoV towards the cost of **Ten Bed Hospital Construction Work at Lekam-05, Rithachaupata** and intends to apply part of the funds to cover eligible payments under the Contract. Bidding is open to all eligible as per Section V of bidding document.
2. Lekam Rural Municipality Office invites electronic bids from eligible bidders for the construction of **Ten Bed Hospital Construction Work at Lekam 05, Rithachaupata** under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.  
 Only eligible bidders with the following key qualifications should participate in this bidding:
  - Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: [Nrs. 14,20,00,000/- (One Hundred Forty Two Million) ]
  - Minimum Work experience of similar size and nature: [One (1) Contract of RCC Framed Building Construction Project within the last ten (10) years with a value of at least Nrs. 9,50,00,000/- (Ninty Five Million) Including VAT]
3. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of IB 21 of the Bidding Document.

7. Electronic bids must be submitted to the office **Lekam Rural Municipality Office Ratamata, Lekam** through PPMO website [www.bolpatra.gov.np](http://www.bolpatra.gov.np) on or before **12:00 Noon on 18-May-2021 (2078/02/04)**. Bids received after this deadline will be rejected.
8. The bids will be opened in the presence of Bidders' representatives who choose to attend at **2:00 PM on 18-May-2021 (2078/02/04)** at the office of **Lekam Rural Municipality Office Ratamata, Lekam**. Bids must be valid for a period of **120 (One Hundred Twenty) Days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of **30,00,000/- (Thirty Lakh Only)**, which shall be valid for **30 days** beyond the validity period of the bid.
9. If the last date of purchasing and/or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
10. **Lekam Rural Municipality Office, Ratamata, Lekam** reserve the right to accept or reject, wholly or partly any or all the bids without assigning reason, whatsoever.
