The Bidding documents may be purchased on or before 30th day from the date of first notice published from the office of the Rural Municipal Executive, Lekam Rural Municipality, Darchula, Nepal by the eligible bidders on submission of written application attaching attested copies of (a) firm registration certificate (b) VAT and PAN registration form (c) tax clearance certificate valid for the F/Y 2075/2076 (d) Power of attorney, and upon submission of a voucher for non-refundable fee of NRs. 3000 (Cost for bid document) deposited in revenue account no. 09011 000089, Laxmi Bank, Lekam Branch as mentioned in the above table for procuring bidding documents from Lekam Rural Municipality, Office of the Rural Municipal Executive, Darchula, Nepal within the office hours.

3. Sealed Bids with necessary supporting documents must be submitted to the office of Lekam Rural Municipality, Office of the Rural Municipal Executive, Darchula, Nepal on or before 12:00 of 31st day from the date of first notice published. Documents received after this deadline shall not be accepted.

4. Bids shall be opened in the presence of Bidders' representatives who choose to attend at 31st day from the date of publication at 14:00 hours at the office of Lekam Rural Municipality.

5. Bids must be valid for a period of 90 days counting from the day of bid opening and must be accompanied by bid security minimum amounting of NRs. 1,38,000 cash deposit in deposit Account No. 09011 000113, Laxmi bank, Lekam Branch or in the form of unconditional Bank guarantee from A class Bank in favor of Lekam Rural Municipality, Office of the Rural Municipal Executive, Kharkada, Darchula, Nepal which shall be valid for minimum 30days beyond the bid validity period.

6. If the last date of purchasing, submission and opening falls on a government holiday then the next working day shall be considered the last day. In such a case the bid validity and bid security validity shall be recognized with effect from the original bid submission deadline.
